Also, to help us align our vision, to set and maintain both long- and short-term goals, and develop the plans to achieve them, the LLPOA Board of Directors is participating in a Strategic Planning Meeting at the end of April. The strategic plan will provide our future boards with a strong foundation and a proactive plan to help navigate the future of our Association.

# **WATER QUALITY - LFA UPDATE**

#### **LFA System**

Monday, April 1, 2024, the LFA system was turned on and marks the beginning of the fourth year of our LFA program.

In 2023 our North Lake achieved four out of six targets while the South Lake achieved three out of six targets. We are struggling with water clarity on both lakes. In 2024 we are addressing water quality by using a BioChar product which is one of the recommendations given to us by our Lake Manager (see below). We will not be using BioBlast in 2024. We will need the support of our lakefront members with the implementation of this new program. The higher the member participation the better our results. Keep an eye out for further information regarding this program.

## Water Quality update from our Lake Manager, Restorative Lake Sciences (RLS)

The overall improvements of the LFA system have been modest relative to muck reduction, increase in dissolved oxygen, and decline in some nutrients. Eurasian Watermilfoil was showing strong signs of herbicide resistance and thus a new systemic herbicide, ProcellaCOR® was used in 2022 and 2023 given its evaluated efficacy and longer-lasting control. Care must be taken to avoid removal of too much aquatic vegetation as this can exacerbate blue-green algal blooms by allowing for less competition from plants for nutrients.

The BioBlast® bioaugmentation formula did not yield desired results over the past Three years and thus RLS recommended the use of TimberChar Nutrient Harvesting Filters® biochar which is an EPA-certified product that has successfully reduced nutrients and solids in other lakes thereby reducing blue-green algal blooms and improving water clarity. This product will be distributed to lakefront owners on Lake LeAnn in 2024 and will be evaluated as a part of the current lake restoration program. Filter bags will also be used to reduce nutrients in the CSA's pending state approval.

## HELPING OUR WATER QUALITY

The Comprehensive Best Management Practices Brochure (BMP), explains all BMPs and how utilizing BMPs can help improve our Water Quality. Please pick one up at the Office or view on-line on our website.

The Office has a Weed Razor for lake weeds and a Leaf Rake to help get leaves out of the lake. These new tools are for Members to borrow. We only ask for a security deposit that will be held until the item is returned.

**Lake Debris Pickup** is available for those members that rake out your lakefront.

This helps keep the excess leaves from feeding the algae and other invasive species of plants. You can take the debris from your lakefront area and place it by the road in front of your house for pick up. Be sure to call the office with your address and our maintenance staff will collect it weekly until Oct 31st. Pick up days are Tuesdays and Wednesdays. LLPOA will pick up only lake debris from lakefront properties. We kindly ask that debris not be in paper or plastic bags.

**Reducing Fertilizer usage** is very important in reducing nutrients that are contributing to the algae.

**Bonfires** should be in be 20 feet from the shoreline and must be in a self-contained fireproof receptacle.

#### SEPTIC SYSTEMS

Members are required to have septic tanks pumped and inspected every five years and provide documentation to the LLPOA office. You have until July 2028 to complete this initial task. The Michigan House and Senate are reviewing bills that the proposed legislation seeks to mandate periodic septic system inspections, and would require homeowners to repair septic systems that are identified as faulty.

#### **NO SHORT-TERM RENTALS**

Most of our Declaration of Restrictions designate that each lot shall be for a private residence and shall not be used for commercial purposes. Michigan Courts have upheld that Short-Term Rentals (less than 30 days) are considered a commercial use of property.

# **BOAT LAUNCH, SECURITY NOTICE:**

If you are interested in the position as a Boat Launch Monitor - please contact the Office for an application.

- No LLPOA 2024 sticker on the watercraft (and MC # on motorized craft) = No launching
- Boat Launch Monitors will be posted at both launches ensuring ALL watercraft has a LLPOA sticker PRIOR to launching.
- Stickers are to be placed on the back of your boat to the right of the motor and above the water line.
- Watercraft owner must be present to activate gate when Marinas deliver watercraft.
- All Members are assigned a new gate code each year. The gate code is on a yellow card with 2024 on the upper

#### NO POWER LOADING

"Power loading" is a term used to describe using the motor to load and unload the boat onto and off the trailer.

Power loading can cause damage to launch ramps that may not be visible from the surface of the water.

Slightly more than idle speed should be all that is necessary to load and/or unload the boat. The best practice is for boaters to refrain from power loading and use the winch to load and unload their boat.

#### BUOYS, NO WAKE SIGNS and ANCHORS

Please do not move, hook or tie off to the buoys.

They are in the locations approved by the DNR.

Bays and channels are No Wake per the DNR Rule WC-30-900-001. Please slow to a No Wake speed in these areas of the lakes.

Please use mushroom type anchors to help protect our LFA system.

#### **MAINTENANCE COMMITTEE**

• **New hire** - We hired Eric Norman to work with Ted King. Eric is no stranger to Lake LeAnn as he has been around our lake for many years. If you see the two of them out and about, please welcome Eric to our team.

- Father Richard Park has been cleared for our maintenance team to take lake weeds and leaves.
- **Shoreline Protection** We are currently working on additional rip-wrap walls on the lakes. Permits have been requested from EGLE and once we have the permits, quotes will be obtained. We expect to see shoreline work start this spring/ early summer.
- **North Boat Launch** This spring/summer we will pave the North Boat Launch. The project will take two days and the launch will be closed during this time. We requested that this be done during the week. The office will send out an email notifying members of the dates.
- **Volunteers** Please note that we are always looking for volunteers to help around the lake with maintenance items. If you are willing to help and have time, please notify the office.

#### **RULES and REGULATIONS COMMITTEE**

- The Committee works on projects assigned by the elected Board of Directors, or suggested by other Members
  of the Association. This can range from clarifying an existing rule to developing a proposal for a by-law change
  for Members to consider at our Annual Meeting.
- Our major project this year has been to extensively revise the Membership Guide in order to provide an easyto-use resource containing all of the rules and regulations, commonly used procedures, and associated forms in a single document.
- We meet remotely the first Tuesday of every month, and the meeting link can be obtained by calling the Office.

Thursday July 4<sup>th</sup> - Starting time is 4:00 pm.

#### **BUILDING PROJECTS**

The BCC was established in the Deed Restrictions as a committee to approve plans for improvements on LLPOA member's property to ensure compliance with the deed restrictions. We encourage you to contact the LLPOA office for any improvement projects and obtain information or visit our website.

# MARKETABLE TITLE ACT (MRTA)

As required by the MRTA Bill passed by our Michigan Legislature in 2019, Notice of Claims for each Subdivision have been filed with Hillsdale County for each Subdivision to preserve the existing Deed Restrictions.

#### **WAKE BOATS**

DNR Recommendations for boats operating in Wake Surf/Board Mode:

- operate at least 500 feet from shore
- operate in water at least 15 feet deep

Michigan legislation has been introduced to help to minimize their risk of endangering swimmers and other passive water resource users, and also help to mitigate their potentially harmful impacts on shorelines, docks, and on fish and wildlife.

## ABSENTEE VOTING REQUIREMENTS AND PROCEDURE

Any member wishing to cast a vote via Absentee Ballot must request an Official Numbered Ballot either in-person at the LLPOA Office, via US Mail or electronic transmission e.g. (e-mail or fax). The following information will be needed in order to obtain an official numbered ballot: Member's Name and LLPOA Account Number.

After submitting your request, the LLPOA Office staff will verify that you are a member in good standing and issue an Official Numbered Ballot.

Ballots must be returned to the LLPOA Office with the following information: Member's Name, Address, Subdivision, LLPOA Account Number and Proof of Official Identification (Driver's License, State ID or passport).

Ballots may be returned in one of the following ways:

- a. In person, by the name on the ballot or by his/her designee
- b. By US Mail

Ballots must be received no later than 15 days prior to the Annual Meeting - Friday May 24th

NOTE: Absentee Voting can be used for all Motions on the agenda, except for Director Voting.
