**BOATS:** – Please read instructions and list your boats below.

- 1) **ALL** watercraft **MUST** have a 2024 **LLPOA** sticker (Teal) to be on Lake LeAnn.
- 2) Stickers are good for one year and need to be renewed annually.
- 3) **The current registration must be in the name of one of the members listed on the front** and a copy must be given to the office to receive a sticker.
- 4) **NOTE** – If your registration expires March 31, 2024, you must renew your registration **prior** to obtaining a 2024 LLPOA boat sticker.
- 5) All boats with an out-of-state registration must be re-registered with the State of Michigan if they are here for the entire summer.
