DESCRIPTION

The land embraced in the annexed plat of "Lake Le Ann - Maquago Hills" Being a subdivision of part of NE 1/4 Sec. 9, T. 5 S., R. I W., Somerset Twp., Hillsdale County, Michigan comprises 21 lots numbered 1 thru 21 both inclusive and Outlot "A" and is described as follows:

Thence along the arc of a curve, radius of 600.00 feet; interior angle of 54 Deg., 30 Min., long chord of 549.45 feet, long chord bearing of S. 62 Deg., 21 Min., 00 Sec. E, a distance of 570.72 feet;

Thence S. 0 Deg., 24 Min., 00 Sec. E, a distance of 114.30 feet to the point of beginning.



